It was also noted that the bid will be awarded to Closner Construction & Sales, Inc. as the lowest, most reasonable and responsible bid and Superintendent Bryan DeAugustine, Travis Hongisto from IDI, and Ron Mariani from the Sinking Fund Committee also spoke to the advantage of Option #4.)
