Chris Marana reported a good start to the school year. The Fall testing cycle for NWEA MAP was halfway done. He thanked UP Rehab Medicine Associates, Target and Faith Lutheran Church for recent donations.

Aspen Ridge Middle School/Athletics Report

Jon Beckman reported on being halfway done with the middle school NWEA MAP testing, the annual 7th grade trip to Clear Lake Education Center, and the enrichment period for the middle school students.
