Hello Parents, Guardians, and Students:

We are pleased to inform you that the NICE Community School District will be participating in the Seamless Summer Option (SSO) as part of the National School Lunch and School Breakfast Programs for the 2021-2022 school year. The great news is that ALL students enrolled in the NICE District can receive a healthy breakfast and lunch at **NO CHARGE** (FREE) to your household each day.

Students enrolled in the Patriot Online Academy (POA) learning from home are still eligible to participate in the District's school meals program. School provided free breakfasts and lunches will be available for pick up at Westwood High School for both Aspen and WHS POA students.

Pick up times will be between 8:30 am and 9:00 am Mondays (for Mon, Tues meals) and Wednesdays (for Wed, Thurs, Fri meals) at the Westwood High School Kitchen Door #4 for both Aspen and WHS students. Meals will not be provided for days which are scheduled half days, early release days, scheduled vacation days, etc. Also if school is closed on a Monday or Wednesday, pick up will be on the following day between 8:30 am and 9:00 am.
